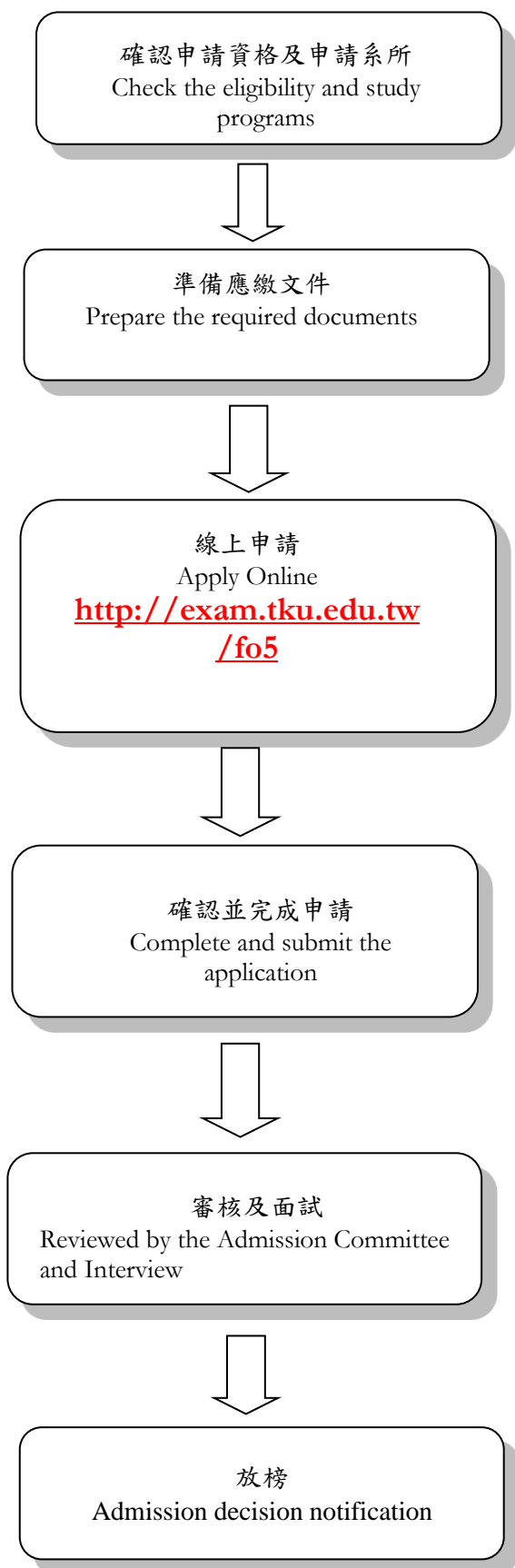

壹、申請資格及相關規定 Eligibility & Related Regulations

一、申請資格Eligibility

※外國學生International Students

(一)具外國國籍並未曾具有中華民國國籍，符合下列規定者。

“An individual of foreign nationality, who has never held nationality status from the Republic of China (“R.O.C.”) and who meets the following requirements, is qualified to apply for admission.

1、未曾以僑生身分在臺就學。

2、未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

1. An individual has never undertaken studies in Taiwan as an overseas Chinese student.

2. An individual has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

(二)具外國國籍並符合下列規定，且最近連續居留海外六年以上者。（計算至2024年8月1日）

An individual of foreign nationality, pursuant to the following requirements and who has resided overseas continuously for no less than 6 years (up to August 1, 2024) is also qualified to apply for admission.

1、申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

1. An individual who also is a national of the R.O.C., but does not hold nor has had a household registration in Taiwan.

2、申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年（計算至2024年8月1日）。

2. An individual who also was a national of the R.O.C. but has no R.O.C. nationality at the time of their application shall have an annulled status regarding their R.O.C. nationality for no less than 8 years (up to August 1, 2024) after an annulment of R.O.C. nationality by the Ministry of the Interior.

3、前二款均未曾以僑生身分在臺就學，且未於當學年度經海外聯合招生委員會分發。以上所定六年，以擬入學當學期起始日期為終日計算之。所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每歷年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

3. Regarding individuals mentioned in the preceding 2 subparagraphs, they must not have studied in Taiwan as an overseas Chinese student nor received placement permission during the same year of the application by the University Entrance Committee for Overseas Chinese Students.

The six year calculation period as prescribed above shall be calculated from the starting date of the semester as the designated due date for the time of study.

The term “overseas” as prescribed above is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the calculated calendar year is not one complete calendar year, their stay in Taiwan should not exceed 120 days within the calculated calendar year period. The only exceptions to this method of calculation are for those who fulfill one of the following requirements with

written supportive proof:

- (1) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
- (2) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
- (3) 交換學生，其交換期間合計未滿二年。
- (4) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。

- (1) Attended overseas youth training courses organized by the Overseas Compatriot Affairs Council or technique training classes accredited by the Ministry of Education;
- (2) Attended a Mandarin Chinese language center at a university/college of which foreign student recruitment is approved by the Ministry, and to which the total length of stay is less than 2 years;
- (3) Exchange students, whose length of total exchange is less than 2 years; or
- (4) An Internship in Taiwan which has been approved by an authorized central government agency, to which the total length of stay is less than 2 years.

- (三) 具外國國籍且原具中華民國國籍，並於外國學生來臺就學辦法中華民國100年2月1日修正施行前（2011年2月1日前）已提出申請喪失中華民國國籍滿八年者（計算至2024年8月1日），得依原規定申請入學，不受前點規定之限制。

An individual, who has foreign nationality and had applied for an annulment of the R.O.C. nationality prior to February 1, 2011 (the effective date of this amendment of Regulations Regarding International Students Undertaking Studies in Taiwan issued by the Ministry) for at least 8 years since the date, on which a revocation was issued from the Ministry of the Interior, up to August 1, 2024, will then be qualified to apply for admission as an international student under the amendment effective before Feb. 1st, 2011 and will not be subject to the limitation of the preceding clause.

※以上所指中華民國國籍係依國籍法第二條規定辦理。

有下列各款情形之一者，屬中華民國國籍：

- 1、出生時父或母為中華民國國民。
- 2、出生於父或母死亡後，其父或母死亡時為中華民國國民。
- 3、出生於中華民國領域內，父母均無可考，或均無國籍者。
- 4、歸化者。

R.O.C. nationality is defined in accordance with Article 2 of the Nationality Act:

A person who meets one of the following requirements has acquired nationality of Republic of China:

- (1) A person whose father or mother was, at the time of his (her) birth, a citizen of the Republic of China.
- (2) A person born after the death of his (her) father or mother who was, at the time of his (her) death, a citizen of the Republic of China.
- (3) A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.
- (4) A naturalized person.

- (四) 具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外連續居留滿六年以上者，得依規定申請入學。所定六年及所稱海外連續居留準用第二點第三項規定。

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or overseas continuously for no less than 6 years is qualified to apply for admission. The six year calculation and the term “resided overseas continuously” mentioned here shall be subject to the preceding second paragraph of the third clause.

- (五) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍，申請時已連續居留海外六年以

上者，得依規定申請入學。所定六年及所稱海外連續居留準用第二點第三項規定。
An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and at the time of application, has resided overseas continuously for no less than 6 years is qualified to apply for admission. The six year calculation and the term “resided overseas continuously” mentioned here shall be subject to the preceding second paragraph of the third clause.

※ 僑生及港澳學生 Overseas Chinese/Hong Kong/Macao Student

(一) 僑生：海外出生連續居留迄今，或最近連續居留海外6年以上，並取得僑居地永久或長期居留證件之華裔學生。

The term "overseas Chinese student" refers to a student of Chinese descent who has come to Taiwan to study, who was born and lived overseas until the present time, or who has been living overseas for six or more consecutive years in the immediate past and obtained permanent or long-term residency status overseas.

(二) 港澳生：香港或澳門居民，具有港澳永久居留資格證件，且最近連續居留境外6年以上；並符合香港澳門關係條例第四條規定。

Hong Kong and Macau Students refer to people who have obtained permanent residence certificates and have recently lived abroad for more than 6 years and comply with Article 4 of the Laws and Regulations Regarding Hong Kong & Macao Affairs.

(三) 港澳具外國國籍之華裔學生：具外國國籍，兼具香港或澳門永久居留資格，未曾在臺設有戶籍，且最近連續居留香港、澳門或海外6年以上之華裔學生，得依「僑生回國就學及輔導辦法(附錄1)」第23條之1申請入學。

Hong Kong and Macau Chinese Students of foreign nationality: Students who not only have foreign nationality, but also have the right of permanent residency in Hong Kong or Macau, who do not hold a household registration in Taiwan, and who have been living overseas, in Hong Kong or Macau, for six or more consecutive years in the immediate past. The study and counseling assistance for Hong Kong and Macau Chinese Students of foreign nationality fall mutatis mutandis under the “Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan (Appendix 1)” Article 23 when applying for university admission, before related laws are amended and enacted.

註一：上述第(一)、(三)項所稱海外，指大陸地區、香港及澳門以外之國家或地區；第(二)項所稱境外，指臺灣地區以外之國家或地區。

Note 1: The term "overseas" mentioned in the above items (1) and (3) refers to countries or regions other than Mainland China, Hong Kong, and Macau; the term "abroad" mentioned in item (2) refers to countries or regions other than Taiwan.

註二：所謂「連續居留」係指每曆年(1月1日至12月31日)在臺灣地區停留期間不得逾120日，否則視為居留中斷。期間係以本簡章申請時間截止日為計算基準日往前回溯推算6年，但計算至西元2024年8月31日始符合簡章所訂連續居留年限規定者，亦得申請，惟須簽具切結書，經僑務委員會、教育部、國際及兩岸教育司就申請截止日至西元2024年8月31日之實際居留情形予以審查，如未符合連續居留年限規定者，將撤銷錄取分發資格。

Note 2: The term "The consecutive years of overseas residency" means calendar years in each of which an overseas Chinese student has not spent more than 120 days in Taiwan. The period is calculated by counting back 6 years from the application deadline specified in

this guideline, but those who meet the continuous residency requirement set by the guideline as of August 31, 2024, may also apply. However, an affidavit should be filled out, and the Overseas Compatriots Affairs Commission, the Ministry of Education, and the Department of International and Cross-Strait Education will review the actual residency status from the application deadline to August 31, 2024. If the continuous residency requirement is not met, the admission qualification will be revoked.

註三：有關連續居留認定及除外規定，不以連續僑居中斷論，僑生請參閱「僑生回國就學及輔導辦法」第3條；港澳生請參閱「香港澳門居民來臺就學辦法(附錄2)」第3條。請於申請時檢附證明文件一併繳交，以利審核。

Note 3: For continuous residence certification and exclusion requirements, overseas Chinese students please refer to Article 3 of the “Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan”; for Hong Kong and Macau students please refer to Article 3 of “Measures for Hong Kong and Macau Residents to Study in Taiwan” (Appendix 2). Please attach the supporting documents and submit them at the time of application for review.

註四：「香港澳門關係條例」第4條規定，所稱香港居民係指具有香港永久居留資格，且未持有英國國民（海外）護照或香港護照以外之旅行證照者；所稱澳門居民，係指具有澳門永久居留資格，且未持有澳門護照以外之旅行證照或雖有葡萄牙護照但係於葡萄牙結束治理前於澳門取得者。不符合前述規定，但「具外國國籍，兼具香港或澳門永久居留資格，未曾在臺設有戶籍，且最近連續居留香港、澳門或海外6年以上之華裔學生」，得依「僑生回國就學及輔導辦法」第23條之1申請入學。

Note 4: According to Article 4 of the “Laws and Regulations Regarding Hong Kong & Macao Affairs”, the term “Hong Kong Residents” as used herein refers to persons who qualify for permanent residency in Hong Kong and who do not hold a travel document other than a British (Overseas) passport or a Hong Kong passport. The term “Macau Residents” as used herein refers to those who have the right of permanent residency in Macau and hold no travel documents other than the Macau passport; or those who do hold a Portuguese passport but obtained the document in Macau prior to the end of Portuguese rule. Those who do not meet the aforementioned regulations, but are “An overseas Chinese student of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or overseas continuously for no less than 6 years” may apply for admission in accordance with Article 23-1 of the “Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan”.

註五：取得僑居地永久或長期居留證件，得以取得僑居地公民權、永久居留權或以其所持中華民國護照已加簽僑居身分認定之。

Note 5: Documentary evidence of the having obtained permanent or long-term residency status overseas may include proof of having citizenship or permanent residency in the applicant’s country of residence, or having a Republic of China passport which officially records the person’s overseas Chinese status.

註六：僑生身分認定，由僑務主管機關為之；港澳生及港澳具外國國籍之華裔學生身分認定，由教育部為之。

Note 6: A person’s overseas Chinese student status must be validated by the Overseas Compatriots Affairs Commission (OCAC). A person’s Hong Kong and Macau Students

or Hong Kong and Macau Chinese Students of foreign nationality status must be validated by the Ministry of Education.

註七：僑生及港澳生回國就學期間，除其他法令另有規定外，不得任意變更身分。若同時符合外國學生及僑生身分資格者，請擇一身分申請入學，一旦提出申請後不得變更身分。

Note 7: Overseas Chinese students and Hong Kong and Macau Students are not permitted to change their status while they are studying in Taiwan, unless permitted to do so under the provisions of some other ordinance. If the student who meet the qualifications for both foreign student and overseas Chinese student status, please choose one status to apply for admission. Once the application is submitted, you cannot change your status.

註八：僑生經輔導回國就學後，在國內停留未滿二年，因故退學或喪失學籍者，得重新申請回國就學，並以一次為限。入學後學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學或喪失學籍者，不得依本項規定申請入學。

Note 8: An overseas Chinese student who received assistance to be assigned to an educational institution in Taiwan who studied for less than two years because they discontinued their studies for some reason or forfeited their student status may lodge another application to come to Taiwan to study, but only one such re-application is permitted. However, if the educational institution in Taiwan where the overseas Chinese student was studying considers that the student's conduct or academic performance was unsatisfactory, or if the student violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of the regulations governing student awards and penalties, the student had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan, based on the provisions of this paragraph.

註九：港澳生經申請來臺就學後，因故自願退學，且在臺灣地區居留未滿二年者，得重新申請來臺灣地區就學，並以一次為限。入學後以操行不及格或因刑事案件經判刑確定致遭退學者，不得再依本規定申請入學，亦不得轉學進入其他學校就讀。

Note 9: An Hong Kong and Macau Student who received assistance to be assigned to an educational institution in Taiwan who studied for less than two years because they discontinued their studies for some reason or forfeited their student status may lodge another application to come to Taiwan to study, but only one such re-application is permitted. However, an Hong Kong and Macau Student who has been dismissed by the educational institution that admitted the student as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to re-apply to study in Taiwan, based on the provisions of this paragraph, and transfer to another university or tertiary college.

註十：本招生對象以當年度自海外回國者為限，不含已在臺就讀高中、國內大學一年級肄業及臺師大僑生先修部結業生，以及緬甸、泰北地區未立案華文中學畢業僑生。

Note 10: The admission is not opened to those who have studied in senior high schools in Taiwan, those who have studied for one year in any university in Taiwan, and the Overseas Chinese, Hong Kong, and Macau Students who have completed the schooling at the Division of Preparatory Programs for Overseas Chinese Students of National Taiwan Normal University, and the graduates from unincorporated Chinese schools in Myanmar and Northern Thailand.

已於臺灣之大學取得學士以上學位者，得向海聯會申請入學碩士以上學程；持中國大陸護照者，應循陸生管道來臺就學。

An overseas Chinese student who has been awarded a bachelor's degree or higher degree from a university in Taiwan who may apply for a graduate program at master's degree level or higher by applying to the University Entrance Committee for Overseas Chinese Students during the annual recruitment period. Those holding a mainland China passport should apply to study in Taiwan through the mainland Chinese students' application process.

二、國際專修部相關規定

Related Regulations of International Foundation Program

(一)外國學生及僑港澳生申請人申請學士班者須具國外高中畢業學歷。

International, Overseas Chinese/Hong Kong/Macao Students can apply with a high school diploma from outside Taiwan are eligible to apply for undergraduate programs.

(二)申請資格須遵守及符合教育部「入學大學同等學力認定標準(附錄3)」和「外國學生來臺就學辦法(附錄4)」之規定。

Applicant eligibility must comply and meet with the “Standards for Recognition of Equivalent Educational Levels for University Admission (Appendix 1)”, “Regulations Regarding International Students Undertaking Studies in Taiwan (Appendix 2)” of the Ministry of Education and “Providence University Admission Regulations for International Students (Appendix 3)”.

(三)國際專修部為1年華語先修課(不須華語基礎) + 4-5年學士學位課程；申請國際專修部者，於申請時得免繳中文能力證明。

The International Foundation Program is 1 Year of Chinese preparatory program (Chinese language beginners are eligible to apply.) and 4-5 years of Bachelor's degree program, the applicant who apply for the International Foundation Program do not need to submit the Chinese language proficiency certificate.

(四)華語先修期間不得轉系或轉學，但於正式修讀學士班專業課程1年後，得於製造業、營建業、農業及長期照顧業、電子商務業及服務類科等相關系所申請轉系或轉學。

Students may not apply to transfer to other department or university during the study in the Chinese Preparation program. However, after studied one year in the admitted department, students may apply to transfer to departments related to Manufacturing Industry, Construction, Agriculture and Long-Term Care fields, E-Commerce and Service Industry.

(五)申請來臺於國際專修部先修華語以一次為限，遇特殊事由中斷，經教育部同意，得再申請一次。於完成申請就學之學校學程後，除申請碩士班以上學程，得逕依本校規定辦理外，如繼續在臺就學者，其入學考試應與我國內一般學生相同。已就讀過我國國內大專校院學士班者，請勿以「新生身分」申請學士班。

Students applying for International Foundation Program in Taiwan shall be limited to one application only. If the students interrupted the study by special reasons, students may apply again after get approved by the Ministry of Education. Upon completion of the course of study, at a school in Taiwan, to which an international student has applied, the student's admission to another school's academic level shall be handled in a manner identical to the admission procedures for local students. An exception is that an application for a master's degree or higher levels of graduate studies can be processed under the procedures of each individual school. Student who had took bachelor's program at Taiwan's universities should NOT apply for bachelor's program as “new students”.

(六)申請國際專修部者，需於國際專修部修業期滿一年內，考取華語文能力測驗A2(含)以上程度始能進入申請學系大一就讀；未達標準者，學校將予以退學處分，並安排學生離境事宜。

Students who enroll in the International Foundation Program need to reach at least A2 level of TOCFL within one year in this program, and then the students can bridge to the department which they applied for. For students who fail to pass the TOCFL level A2 are subject to withdrawal from the school and arrangements the departure of Taiwan

(七)本校國際專修部招生事務，不委託校外機構、法人、團體或個人辦理相關事項。

The recruitment of International Foundation Program in Tamkang University is not permitted to commission any external institution, legal person, group, or individual to handle related matters.

In the event that Tamkang University (hereinafter referred to as the “University”) needs to collect, process or use your personal information (based on minimum requirements without handling unnecessary personal information) for the purpose of admission, examination affairs execution, public notice posting, information (communication) and database management, statistical analysis, student data management after admission and any other related or necessary purpose, such collection, processing or use will be conducted in adherence to the following principles by upholding your rights and in good faith. In order to protect your rights and facilitate your understanding of how the University collects and uses your personal information, please make sure that you carefully read all of the contents in this notification (If you are under the age of 20, please notify your legal representative or custodian of the following details).

1. Name of the institution: Tamkang University (hereafter referred to as the University).

2. Purpose of collecting personal information:

The personal information is collected exclusively for the purposes of executing examination affairs related to the college entrance exam (134) (“Items for Specific Purpose” stipulated in “Personal Data Protection Act”, the same should apply hereinafter), providing information (communication) services concerning examination results, recruitment, distribution, use of certificate (135), information (communication) and database management (136), educational research and statistical research analysis (157), student (staff) data management (158), academic research (159) and any other task which is necessary for the completion of the college entrance examination or any other purpose consented by the examination candidate.

3. Method of collecting personal information:

- (1) Direct collection of your personal information by the University, e.g. personal information of candidates sent by candidates in person, or acquired through postal mail or the registration made on the Internet
- (2) Indirect collection of your personal data by the University through specializing institutes (e.g. College Entrance Examination Center and Testing Center for Technological and Vocational Education), research institutes or schools (e.g. universities, senior high schools and vocational high schools).

4. Categories of personal information:

The personal information of candidates collected by the University is the information required for the two categories of examination affairs: basic data, and application for special examination arrangements for candidates with special needs:

(1) Basic information:

Personal information categories, such as individual identifier (C001): (“Specific Personal Data” stipulated in “Personal Data Protection Act”, the same should apply hereinafter), financial condition identifier (C002), identifier within government information (C003), personal profile (C011), resident certificate in the case of immigrant (C033), occupations (C038), licenses or other permits (C039), school records (C051) and qualifications or records (C052), occupational forte (C054), publications (C056), students (participants), examination participation records (C057), current status of being employed (C061), course of employment (C062), course of employment departure (C063), work experience (C064), training records (C072), which entail name, number of national identification card (including resident certificate) or passport, date of birth, photo, gender, education information, emergency contact person, resident address, email address, contact information, fund transfer account (to provide registration fee for low-income households and lower middle-income households), education qualification, professional technique, job title, job description, period of employment, past jobs, service record, military service record, certificates of low income household and lower middle-income household.

(2) Application for special examination arrangements:

In addition to the above information, health records (C111) and examinee records (C057) will be collected

in the case of the application for special examination arrangements by candidates with special need (disabled candidates, candidates suffering from sudden injury or illness).

5. Processing and use of personal information:

(1) The period within which the personal data can be used:

Unless otherwise stipulated by the law or the central competent authority in respect of the retention period of personal information obtained from the holding of examination, the retention period of the personal information by the University shall be the time required for the above purposes for collection to be fulfilled.

(2) The area where the personal information is used: The Taiwan area (including Penghu, Kinmen and Matsu) or the regions agreed or authorized by you for information processing and use. .

(3) Object of the use of personal information:

Those that are eligible to use the personal information shall be extended to respective units of the University. The health records of examinees who apply for special examination arrangements shall be used exclusively by the University for the purpose of providing examination services and may not be used for any other purpose.

(4) Methods of using the personal information:

Methods which are necessary for the execution of examination affairs, admission, reporting to the University, verification, registration, management of new students by the University, contact with candidates (parents, guardians), disclosure required to ensure the integrity of examination affairs (public notice posting), academic research and any other method (“Items for Specific Purpose” stipulated in “Personal Data Protection Act”, the same should apply hereinafter) which is required for the fulfillment of the above collection purposes.

6. Candidates may request to inquire, review or make duplications of the personal information, supplement or correct the personal information, request to discontinue collection, processing or use of personal information and request to delete the personal information according to the Personal Information Protection Act. When exercising the above right, a candidate shall submit application after his/her identity has been verified in accordance with the regulations of this university. If an application is made by an entrusted person, a letter of authorization shall be submitted together with the identification document of the entrusted person for verification. However, it is not limited to the circumstance where the University is obligated by law to preserve the information, keep it confidential and ensure its integrity.

If an applicant fails to meet the above requirements, the University may request the applicant to provide supplementary information in order to proceed with the application.

7. All candidates shall make sure that the personal information provided is true and accurate. If any personal information of a candidate is untrue or to be modified, the candidate shall promptly submit the relevant supporting document to the University for such correction.

8. Please be reminded that a candidate’s failure to provide true and complete personal information may lead to his or her inability to register for the examination or to be contacted during emergency, or the failed delivery of examination results, which will adversely affect the candidate’s participation in the examination, the subsequent examination affairs and the candidate’s receiving of examination services.

9. The University may provide personal information or the relevant information according to the law or upon the request by the central competent authority or the judicial authority.

10. Some of the University’s websites will record user’ IP address, using time, browser, browse and clicked data, etc. The records will only be used as the reference for the University’s management and improvement of its website service.
